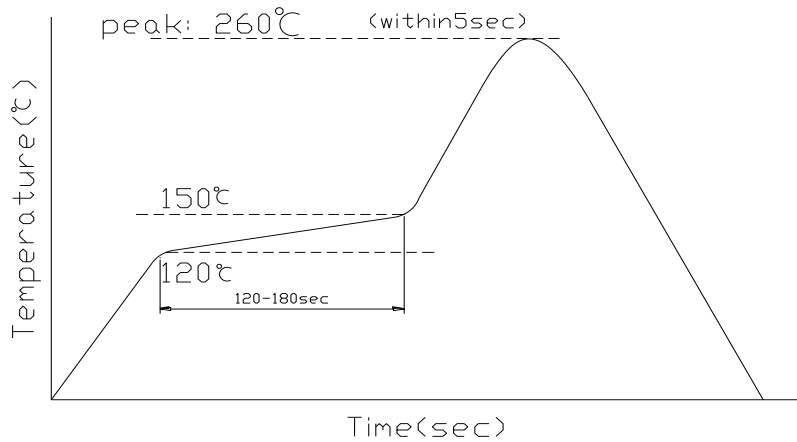
**Characteristic Curves For InGaN:**
